Research & Development Code of Ethics: CE-22

This Code of Ethics for Research and Development, referred to as CE-22, comes into effect immediately upon its approval on 12/07/2022. All points and aspects shall be followed unless changes are explicitly deemed necessary. Any changes or modifications to CE-22 will be incorporated through annexures until the next revision of the Code of Ethics document is prepared.

A. Academic Freedom, Integrity and Responsibility

Academic freedom is the freedom to teach study and enhance knowledge through research activity without undesirable interference or restriction from law, institutional rules and regulations or public pressure. Its basic elements include the freedom of scholars to inquire into any subject that evokes intellectual concern, to present findings, to publish data and conclusions without control or plagiarism and to teach in the manner they consider professionally appropriate.

At the same time, integrity, accountability and responsibility in conducting academic research form the cornerstone of any academic person and violations of widely-recognized academic research standards represent serious offences to the entire academic community at NRIIT.

Academic integrity requires that academic research follows elevated professional standards, including appropriate research design and frameworks, adheres to high levels of research ethics and abides by the requirements set out by professional and regulatory research guidance and research ethics frameworks issued in appropriate areas.

The definition of research includes the following:

a) Basic Research: experimental and theoretical work undertaken to acquire new knowledge of the underlying foundation of phenomena and observable facts, without any particular application or use in view.

b) Strategic Research: applied research that is in a subject area which has not yet advanced to the stage where eventual applications can be clearly specified.

c) Applied Research: work undertaken in order to acquire new knowledge. It is, however, directed primarily towards practical aims or objectives.

d) Creative Work: the invention and generation of ideas, images and artefacts including design.
Usually applied to the pursuit of knowledge in the arts.

e) Consultancy: the deployment of existing knowledge and resource for the resolution of specific problems presented by a client, usually in an industrial or commercial context.

Principles and Values of Academic Integrity: Academic integrity is defined in terms of the commitment and promises to the values of honesty, trust, fairness, respect, sincerity &responsibility, strive for consistency, legality and dissemination.

Honesty: An academician should honestly report the data, results, methods and procedures, and publication status without fabricating, manipulating or misrepresenting data.

Trust: An academic excellence in NRIIT should foster an environment of mutual faith to encourage the free exchange of ideas and enable all to reach their highest potential.

Fairness: An academic body of this institute should seek to ensure fairness in institutional standards, practices and procedures as well as fairness in interactions between members of the community.

Respect: An academic environment of NRIIT should promote respect among students, staff and faculty: respect for self, for others and treat them fairly for scholarship and research, for the educational process and intellectual heritage.

Responsibility: An academic community of NRIIT should uphold high standards of conduct in learning, teaching and research by requiring shared responsibility for promoting academic integrity among all members of the community by striving to promote social good and prevent or mitigate social harms through research, public education, and advocacy.

Legality: An academic committee should observe the valid legal norms related to the conduct and publication of research particularly in relations to copyright, the intellectual property rights of third parties, the terms and conditions regulating access to research resources and obey relevant laws and institutional and governmental policies.

Communication: R & D committee of this institute should seek to make the results of its research as widely and as freely available as possible.

Non-Discrimination: The institute should avoid discrimination against colleagues or students on the basis of sex, race, ethnicity, or other factors that are not related to their scientific competence and integrity.

Confidentiality: The institute should protect the confidential communications, such as papers or grants submitted for publication, personnel records, trade or military secrets, and patient records.

B. Institutional Responsibilities

Head of the Institute, Deans, Head of the department together with the other faculty members, are responsible for promoting and endorsing a transparent academic environment conducive to the application of the high professional and ethical criteria of good practice for academic research. Senior faculty members are expected to create and sustain a atmosphere of mutual co-operation that facilitates the open exchange of ideas and the development of academic research skills.

C. Publication Practice and Authorship, Notification, Archiving and Depositing Copies of Research Publications with the Institutional Repository (IR)

NRIIT encourages the publication and dissemination of results of high quality research. It also expects that researchers will engage in the process of publishi and dissemination of their work responsibly and with an awareness of the consequences of any such dissemination in the wider media. Results should be published in a form appropriate to the academic discipline.

D. Tasks of the Ethics Committee

- To provide advice and guidance to the NRIIT faculty members on all matters pertaining to academic research ethics
- To advise the Academic Council on compliance with the 'Code of Ethics in Academic Research' of the various academic activities at the NRIIT
- To provide guidance and academic support to students on ethical issues in respect of teaching, research and other academic activities. On an entirely voluntary basis, researchers mayask the Ethics Committee for consultation on ethical aspects of their research.
- To confirm to external parties on behalf of the NRIIT compliance with ethical standards in respect of research projects undertaken.
- To advise the Academic Council of any policies that may be required in relation to accepting funds from particular sponsors of research
- To act as an investigative/consultative body for any disputed matter concerning research ethics and conduct.

E. Appointment and Composition of the Ethics Committee

The Ethics Committee shall be approved by the Academic Council upon nomination by the Principal. The Committee shall be composed of the following voting members:

1.0 Profile of NRI Institute of Technology, Agiripalli

10.0 Policy of encouragement

Teaching and Research are the main functions assigned to the faculty of the institute. Teaching is a primary function that needs to be performed at the highest level of competence and this is possible only when the faculty is involved in the research activities. Research essentially nourishes the academic program and updates the faculty about the advances in their field of expertise. Importantly, it helps the institute to stand at the global level.

11.0 Funded Projects and Consultancy Work

The general guidelines for faculty engaging in research, development and consultancy are as follows:

11.1. Basic Guidelines

- i. Every research proposal shall pass through a multi-tier review, where the proposal shall be reviewed by Department Research Committee (DRC) and forwarded to the Institute Research and Development Cell.
- ii. All applications related to R&D shall be routed through the principal along with one hard copy for R&D records. A soft copy shall also be emailed to the R&D coordinator, department R&D cell and also to the Head of the Department.

iii. Separate stock registers shall be maintained for the entire R&D for the externally funded projects in every department.

iv. Purchase of equipment, software and submission of the audit report thereof shall follow the Finance Officer guidelines,

v. Principal Investigator and Co-Investigator shall ensure that the equipment and software purchased are maintained in the laboratory/ department and shall be entered in the stock

vi. The entire sanctioned amount shall be utilized as per the guidelines of the funding agency.

vii. In case the Principal Investigator leaves the institute, the Co-Investigator takes the responsibility as per norms.

Viii. All Heads of the Department must regularly and diligently update the R&D information on the institute website and give reports to R&D team.

11.2. Progress Report submissions

The faculty members eligible for R&D incentives shall submit the report with supporting documents to the DRC every year. The DRC carries out a rigorous scrutiny at the Department level and sends

The R&D cell recommends Intellectual Property Policy guidelines to the administration. In case of any innovation NRIIT encourages the researcher to patent it; the R&D cell creates awareness about intellectual property rights among faculty, researchers and scholars from time to time.

Receiving patent for one's research work is one of the most important factors denoting the quality of research. Full financial and legal assistance shall be provided to those who are interested in registering for the patent. The patent shall irrevocably be registered in the name of NRIIT with the researcher's name prominently featuring as the inventor. The commercial aspects shall be mutually worked out between the institute and the researcher. If patent is filed by the individual(s), then institute may be borne 50% of expenses upon the recommendations of R&D Cell.

11.4. Research & Development Budget

The Heads of the Department shall include R&D component in the yearly department budget proposal. The same is forwarded to the Principal.

11.5 Academic Research Policy

- a. Faculty publication in either IEEE or WEB OF SCIENCE or SCOPUS indexed journals are appreciated with appropriate incentives. The publication target has been set as one IEEE/web science/ Scopus publication for faculty having more than five years of experience.
- b. Individual Citation Score needs to be improved by publishing in reputed journals. c. All publications and research papers of faculty have to go through plagiarism check.
- d. Term papers of B.Tech and M.Tech / MBA projects shall be research focused. Every project shall lead to at least one research publication in indexed journal.

11.6. Sponsored and Internal research related policies

a. Faculty shall apply for a minimum of one government funded project.

b. All departments shall strive for recognition by National/International agencies through schemes/funding from agencies such as AICTE, DST, UGC, ICMR and DRDO.

c. Faculty are encouraged to identify inter-disciplinary research in their field of expertise.

- d. The faculty of all the departments shall tie-up with industries and undertakes funded research in emerging areas and industry relevant areas.
- e. The university shall create special research groups to concentrate on research in government
- f. All innovative projects of faculty are earmarked for filing patents on successful completion. Suitable recognition and incentives are given to those faculty members with patents.

g. Norms are fixed to pay expenses towards procurement of equipment to those faculty members working on funded projects.

- h. Consultancy assignments must have a letter from the organization, clearly mentioning the work to be carried out, period and value of consultancy and the benefit of the consultancy to the institute - both intellectually as well as financially. Proof of expenditure must be maintained by the consultancy incharge.
- i. Meritorious research work/consultancy by faculty is awarded with monetary incentives. The management will suitably reward the recommended projects during the college day and through the incentive scheme. Based on the cells recommendation, financial incentives upto one month salary is given for deserving cases.

11.7. Principal Investigator (PI)

Principal Investigator (PI) of a sanctioned project is considered to be the prime interface between the funding agency and is the operational head of the project. The PI is advised to keep the whole project team aware about the progress of the project and involve the Co-PIs in all related project activities. In


